Affidavit of eligibility for director position

In accordance with Article IV, Section (b), of Articles of Incorporation and Bylaws of East Central Energy

Further, Affiant states that he/she has reviewed and thoroughly understands the terms and requirements of the **Conflict of Interest Disclosure Statement** that is attached hereto and agrees to complete and sign the questionnaire included in such **Conflict of Interest Disclosure Statement** at the same time as this Affidavit is signed by Affiant.
- Affiant also states that he/she has reviewed and understands the Director's Code of Conduct and the ECE Board of Directors Confidentiality Agreement that further govern the actions and conduct of the Directors.
- 6. Affiant agrees that if he/she is duly elected as a Director, that he/she will immediately sign and agree to be bound by the **Director's Code of Conduct** as well as the **ECE Board of Directors Confidentiality Agreement.**
- 7. Affiant further recognizes that by signing this Affidavit and the attached **Conflict of Interest Disclosure Statement**, he/she is representing to ECE and its members that he/she meets the eligibility standards required of ECE Directors, as discussed above, and that he/she is not aware of any fact that would disqualify him/her from serving as a Director, if so elected.
- 8. And finally, Affiant agrees to promptly notify the ECE President/CEO in the event that Affiant's eligibility status changes so as to bring in to question his/her right to continue as an ECE Board candidate or to continue in office as a seated ECE Director.

Further, Affiant states that this Affidavit is being signed for the primary purpose of assuring ECE and its members that the undersigned Affiant is eligible and qualified to be a candidate for a director position on the ECE Board of Directors. Affiant hereby agrees to be bound by the ECE Director's Code of Conduct, Board of Director's Confidentiality Agreement and Exhibit G, Addendum to ECE Board Policy PD-19.
